

Accommodation and care fees

St Peters

St Basil's has priced its accommodation to reflect the facilities and the level of comfort and lifestyle services that are available at each of our sites at St Peters, Croydon Park and Aegean Village at Christie Downs.

1. Basic Daily Fee

Everyone contributes this fee, which helps support the daily services provided at the home. The rate is fixed at 85% of the single basic aged pension and adjusts in March and September each year to match changes in the pension.

2. Non-clinical Care Contribution

Some residents may need to pay extra for their care, based on a means assessment. You'll be informed if this applies to you and how much to pay. The Non-clinical Care Contribution is capped at a lifetime limit or four years, whichever comes first.

3. Accommodation Costs

You may need to pay an Accommodation Payment, which covers your accommodation costs. The government may pay some, all, or none of this amount, depending on your circumstances. If you're not eligible for government assistance, you can pay by:

- Refundable Accommodation Deposit (RAD): a lump sum, refunded with a 2% p.a. retention fee calculated daily (capped at 5 years), or
- Daily Accommodation Payment (DAP): a monthly payment calculated with a government-set, CPI-indexed interest rate (MPIR), or
- A combination of RAD and DAP: partially refundable lump sum plus non-refundable daily payments.

4. Hotelling Supplement Contribution

Residents who are able to cover the full cost of their accommodation may also be responsible for daily living expenses, including food, cleaning, laundry, and utilities. The specific contributions required will be determined by your assessment.

5. Higher Everyday Living Fee

The Higher Everyday Living Fee is an opportunity for you to purchase additional goods and services. Information regarding this fee is available separately.

Originally a sprawling bluestone building with an impressive history, St Peters has been renovated to accommodate the lifestyle preferences of our residents. This boutique facility features 32 bedrooms and is situated on a spacious corner plot in the tranquil, tree-lined neighbourhood of St Peters.
